# MESSAGE FROM THE CHAIR OF THE BOARD OF DIRECTORS

Although 2019 was a challenging year for attracting investment in mineral exploration, British Columbia continues to have success on the global mineral exploration and mining stage. Natural Resources Canada and regional geologists with the B.C. Geological Survey report that exploration activity has declined slightly, but companies in all regions of the province reported new discoveries and significant results. Provincial numbers for 2019 from the fourth annual “British Columbia Mineral and Coal Exploration Survey” will be released in early 2020. This survey is undertaken annually in partnership with EY and the Government of British Columbia’s Ministry of Energy, Mines & Petroleum Resources.

A recent trend in the Canadian mineral sector is a steady increase in reinvestment by major mining companies into junior explorers. For example, Galore Creek Mining Corporation is a 50/50 partnership between Newmont Goldcorp Corporation and Teck Resources Limited and in August 2019, Newcrest Mining Limited completed a 70 per cent acquisition of the Red Chris copper-gold mine in northwest B.C. from Imperial Metals Corporation. Another positive for our industry occurred in January 2019, when the Government of British Columbia announced the adoption of the B.C. Mining Task Force’s recommendation to make the provincial mineral exploration tax credit (METC) and the Mining Flow-through Share tax credit permanent incentives. This positive development, will hopefully encourage an increase in exploration funding in B.C. and motivate other provinces with similar provincial METC mechanisms to take similar actions.

The Northwest region of British Columbia, which includes the “Golden Triangle”, is now well resourced via a series of infrastructure investments and has become a strong, vibrant and competitive mineral exploration hub. The success in the region is due in large part to the strong support from First Nations for sustainable resource development that bring jobs and economic opportunities. In January 2019, the government provided \$1 million in funding for the continuation and expansion of the B.C. Regional Mining Alliance (BCRMA) to collaboratively promote B.C. as a leading jurisdiction for mineral development. Throughout the year, the BCRMA has been actively sharing our success stories, partnerships and best practices with the global investment audience. The group attended the Northern Miner Conference in London, the Precious Metals Summit in Colorado and the New Orleans Investment Conference this year.

AME commissioned a study of the economic impacts of mineral exploration to B.C., including communities and Indigenous groups across the province. The results show that a typical exploration project has a small and temporary footprint with broad-ranging benefits to the economy. In 2018 there were \$331 million in exploration expenditures, and \$4.9 billion over the past 15 years. The discoveries of the past 15 years have brought mines such as Brucejack, New Afton, Mount Milligan, Red Chris and Copper Mountain into production; 97% of these expenditures stay in B.C. and contribute to our provincial economy in more than 150 local communities. Also, Vancouver continues to be a global centre of excellence in the minerals and metals industry, with more than 800 exploration companies and 1,200 service and supply companies based in the city. In September, AME was part of the Mining Breakfast panel at the Union of B.C. Municipalities (UBCM) conference to discuss these findings along with the Mining Association of British Columbia (MABC). MABC kicked off their second One Province One Economy campaign and announced the findings from a recent industry study that, in 2018, mining generated \$12.3 billion in economic activity, more than 33,000 direct and indirect jobs, and \$1 billion in direct payments to government to support healthcare, education and public services. The breakfast was attended by local government and community leaders from across the province. This year has certainly seen AME leverage many partnerships and collaborate on various initiatives.



I have enjoyed the privilege of being the Chair of AME's Board of Directors and to work with AME staff and industry colleagues over the past year. I would like to acknowledge Ms. Edie Thome for her leadership of AME as President & CEO over the past two years and her work in portraying our industry as a diverse and progressive one with government and stakeholders. Although we were sad to see Edie leave AME for Toronto, we gained a new President & CEO in our former Chair, Ms. Kendra Johnston, whose enthusiasm for, and knowledge of our industry, are assets for AME. I am proud of the work we have done together and would like to thank my Executive and Board colleagues, our many volunteers and our staff for their efforts to support AME and our industry through lean times and to prepare it for the good times to come.

# MESSAGE FROM THE PRESIDENT & CEO

On behalf of everyone at AME, I would first like to thank you for the opportunity to represent you, our vast and dynamic membership, through a time of change and progress.



In January 2019, AME hosted another successful Roundup conference. More than 6,500 delegates enjoyed our tried and true networking events such as B.C. Night and an excellent array of technical information from short courses and technical sessions to the Core Shack and Prospectors' Tent. In addition, we held the second annual Reconciliation Breakfast, hosted a variety of cutting-edge exhibitors in the Innovation Hub and new exploration projects in the Project Generators Hub. We generated lots of media buzz and earned coverage for AME, Roundup, Discovery Day, and the B.C. Regional Mining Alliance. There was 1,169 pieces of editorial coverage, with a total reach of 172 million impressions. This was an increase of 38 percent over 2018.

Our regulatory and policy staff participated in multiple engagement and consultation sessions on both provincial and federal legislative and regulatory developments. The provincial government committed to building a strong, sustainable, innovative economy by creating good-paying jobs in every corner of B.C. A healthy and growing mineral exploration and mining sector is foundational to achieving that goal. To this end, the B.C. Mining Jobs Task Force (MJTF) was created in February 2018 to identify measures to create and sustain good jobs in this foundational industry. At Roundup 2019, Premier Horgan committed to completing the 24 action items resulting from the MJTF report and announced that the B.C. Mineral Exploration Tax Credit (B.C. METC) and the B.C. Mining Flow-Through Share Program would be permanent tax incentives in B.C. at a rate of 20% each. In addition, government committed \$1 million to work with industry and all levels of government to develop a mining innovation roadmap, and an additional \$1 million for the continuation and expansion of the B.C. Regional Mining Alliance (BCRMA), which through partnership with Indigenous communities and industry, promotes B.C. to the international investment community. Additional funds were also allocated to the Ministry of Energy, Mines and Petroleum Resources (EMPR) for new staff to increase oversight, improve permitting timelines and support indigenous engagement, all key priorities for the industry and our members. Permitting timelines and processes remain a heightened priority for us as we move into 2020. We are encouraged by recent changes being made at EMPR and look forward to their implementation in the new year.

In the fall, AME participated in a multi-stakeholder working group to engage on the most prevalent new legislation in recent history, Bill 41 which enacted the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) into law in British Columbia. The new law is closely tied to the provincial government's goal, across all ministries, of advancing reconciliation in B.C. Upon introduction of the Bill into the legislature, AME commented via a news release and an opinion piece co-authored with the Tahltan Central Government and expressed our support for the goal of the legislation to advance reconciliation with First Nations and the

objective to reduce uncertainty for users of the land base. We commented that over time, as provincial laws are brought into alignment with UNDRIP, we are cautiously optimistic that this legislation and its implementation will lead to a clear, transparent and timely project review process to attract the capital needed to develop our natural resources for the benefit of all British Columbians. We also emphasized that the BC mineral exploration and mining industry is at the forefront of advancing reconciliation through agreements and partnerships with local Indigenous communities that embody the principles of UNDRIP. We understand that the hard work is yet to come regarding the collaborative development and implementation of the action plan and are looking forward to working with government and First Nations to move this forward.

We are looking forward to seeing you at Roundup 2020, to hearing what you've been up, what your challenges are, and where you see potential opportunities. Please take the time to stop us in the halls and give us your feedback; our job is to serve you, our membership and the more feedback you can give us, the better we can serve you.

In closing, please accept my heartfelt thanks to the amazing volunteers, Board and Executive team and staff. The Association has a strong, credible and important voice because of each of you.

# AME'S 2018-2022 STRATEGIC PLAN PRIORITY AREAS:

## PROGRESS IN 2019

### SUCCESSFUL EXPLORATION

SUCCESSFUL PROJECTS ARE DEVELOPED EXPEDIENTLY FOR THE BENEFIT OF ALL BRITISH COLUMBIANS MAKING BC THE MOST FAVOURED JURISDICTION IN CANADA FOR MINERAL EXPLORATION AND DEVELOPMENT.

#### Goals:

- Maintain access to the current land base;
- Increase regulatory predictability;
- Increase economic viability and confidence;
- Integrate social responsibility;
- Promote relevant and useful geoscience.

#### 2019 highlights include:

• **Exploration tax incentives made permanent.** The decision was announced in January at Roundup by B.C. Premier John Horgan. The Mining Flow-Through Share Tax Credit and the B.C. Mining Exploration Tax Credit are now permanent incentives that support investment in the industry and drive job growth. AME is continuing to advocate for additional tax incentives for mineral explorers as well as the formation of a new government-initiated investment fund.

• **B.C. Mining Jobs Task Force (MJTF) implementation begins with Budget 2019.** The MJTF report was released in January, and the B.C. Budget 2019 was announced in February. In the budget, the provincial government committed \$1 million to collaboratively develop a mining innovation roadmap and to move forward with the adoption of all the action items from the report to boost the mining sector and create good jobs and a strong, sustainable economy.

• **Expansion of the B.C. Regional Mining Alliance (BCRMA).** The government committed an additional \$1 million for the continuation and expansion of the B.C. Regional Mining Alliance, which promotes investment in mineral exploration and mining in B.C. through a unique and strategic collaboration with AME, the Province, the Tahltan Central Government, the Nisga'a Lisims Government and several exploration companies working in northwest B.C.

#### • **Submission on the Proposed National Park Reserve Concept in the South Okanagan-Similkameen.**

AME will continue to engage with mineral tenure holders, Parks Canada and the B.C. government regarding clarity on timelines and a final boundary.

• **Welcomed Kendra Johnston, PGeo, MBA** to the staff as the new President & CEO in June 2019.

• **Attended the 76th Annual Energy and Mines Ministers Conference.** In July, AME attended the 76th annual Energy and Mines Ministers Conference to liaise with senior government officials and mineral industry associations from across Canada. The Canadian Mineral Industry Federation, of which AME is a member, released a brief that included recommendations for government action to ensure Canada remains a globally competitive jurisdiction and can continue to attract mineral investment.

• **Commented on Forest and Range Practices Act Engagement.** In July, AME submitted its response to the B.C. Ministry of Forests, Lands, Natural Resource Operations and Rural Development (FLNRORD). AME's submission outlined the need for ensuring continued access to mineral tenures and areas of B.C. with high mineral potential. AME urged the province to provide early notice to users when deactivation is contemplated and provide opportunities for users to collaborate and suggest alternatives to full deactivation where practical.



• **Hosted a Deputy Ministers meeting** on September 20 with provincial government Deputy Ministers John Allan, Dave Nikolejsin, Don Wright, Mark Zacharias, Doug Caul and Assistant Deputy Minister Peter Robb as part of a regular series of meetings with deputy ministers. Discussions were centered on the state of the industry including financial barriers, industry perception, environmental assessment, caribou, species at risk, wildlife, land use planning, reconciliation, permitting and compliance and enforcement.

• **S11 Conservation and Partnership Agreements for the Southern Mountain Caribou.** AME continues to engage with B.C. Ministry of Forests, Lands, Natural Resource Operations and Rural Development, the lead ministry, to discuss the agreements and work plans in more detail.

• **Submitted a paper on the Proposed Changes to Tax Treatment of Employee Stock Options** tabled by the federal Finance Minister in June. As part of consultation in September, recommended that non-CPC's with revenue below \$100 million in either of the last two fiscal years, as reflected in consolidated financial statements for such fiscal years, should be exempt from the newly proposed \$200,000 limit. Such a prescribed condition, as suggested by the Prospectors & Developers Association of Canada, would ensure that mineral exploration and development companies can attract and retain the talent they need to successfully explore in remote areas with few economic development opportunities.

• **Study on the Impacts of Mineral Exploration to B.C.** AME commissioned a study of the economic impacts of mineral exploration to British Columbia, and its communities. The results show that a typical exploration project has a small, temporary footprint, but with broad-ranging benefits to the economy and 97% of expenditures remaining in the province.

• **Attended the Union of B.C. Municipalities (UBCM)** annual meeting from September 23 to 27. Kendra Johnston participated in a panel at the Mining Breakfast, hosted by C3 Alliance.

• **Environmental Assessment Stakeholder Implementation Committee** AME was a member of the Environmental Assessment Offices's implementation committee that provide review, comment and guidance on a wide range of regulations, policies and guidance documents that will support B.C.'s new environmental assessment act that went into force in December 2019. This included commenting on proponent fees, the reviewable projects regulation and how the positive effects of a project are assessed.

• **Water Sustainability Act** When the Water Sustainability Act (WSA) came into effect in 2016, AME successfully advocated for a temporary allowance for mineral exploration activities to divert water without requiring a permit under the WSA. This temporary allowance was extended each year through 2019. In late 2019, in large part due to AME's advocacy, this exemption became permanent with the additional provision of allowing the diversion of water for camps that provide living quarters for up to 20 people.

• **Health, Safety and Reclamation Code Review Committee** AME was invited by the Minister of Energy Mines and Petroleum Resources to be a member of the Code Review Standing Committee for an initial term of three years. The Health, Safety and Reclamation code is the primary vehicle to regulate the mineral exploration and mining industry in BC. AME will ensure the views and perspective of the mineral exploration sector are represented on any proposed amendments to the code.

• **Permitting workshops and advocacy** Permitting of mineral exploration projects in a timely and streamlined manner continues to be a high priority for AME. Over the past year, AME has held a number of workshops and meetings with government officials and AME members to identify key issues and work toward solutions. We are encouraged by the progress and expect to see improvements in the permitting process in 2020. AME will continue to be active on this file throughout 2020.

• **Professional Reliance** In March, AME commented on proposed regulations for the Professional Governance Act that was passed by the BC government in November 2018. Comments focused on the practice rights of professionals, regulation of firms, and proposed requirements for competency declarations and conflict of interest declarations.

• **Joined the B.C. Geological Survey's Technical Liaison Committee** in November which helps guide the direction of provincial geoscience.

• **Completed the review of AME's Guiding Principles:** Staff and relevant committees with support from Hatfield consultants completed a review of the guiding principles. These four new Guiding Principles were approved by the Board and can be found on AME's website. They are Environmental Stewardship; Indigenous Relations; Social Responsibility and Health and Safety.





## PUBLIC AWARENESS AND STAKEHOLDER EDUCATION

PREDICTABLE PUBLIC SUPPORT THROUGH INFORMED AND COLLABORATIVE DIALOGUE.

### Goals:

- Create and leverage partnerships;
- Build on marketing and communication expertise of members; and
- Expand audience outside of the industry.

### 2019 Highlights include:

- **Funded seven regional exploration groups** for public outreach and education activities.
- **Increased Roundup media coverage** for 2019. AME received 1,169 pieces of editorial coverage published in mainstream and trade publications, with a total reach of 172 million; this was an increase of 38% over 2018.
- **Hosted Discovery Day**, a free family-friendly event at Roundup, open to the public. Total of 41 pieces of editorial coverage and event listings with a total reach of 4.5 million impressions and five broadcast interviews featuring Rob Stevens and Danielle Mountjoy on OMNI and Steve Irwin, Andy Randell, and Kendra Johnston on Breakfast Television.
- **Conducted a public survey of 800 British Columbians and analyzed results based on four distinct groups.** The groups were analyzed based on their attitudes toward economic development, environmental protection, information consumption habits and their knowledge of the mineral exploration and mining industries. The findings indicate that 63% of those surveyed were not familiar with mineral exploration. The results are being used to inform the public outreach campaigns.
- **Completed the Public Engagement and Awareness Program (PEAP) three-year Strategic Communications Plan** based on survey results. The goals of the PEAP are to; increase public awareness of minerals and mineral exploration; increase understanding of the necessity of minerals and metals and; improve understanding of the benefits and impacts from mineral exploration and mining on communities.
- **Finalized a Memorandum of Understanding with Britannia Mine Museum** and have collaborated with the **Mining Association of B.C. (MABC) MineralsEd, Britannia Mine Museum and The Prospectors and Developers Association of Canada (PDAC)** on several projects, partnerships and initiatives.



## INDIGENOUS RELATIONS AND RECONCILIATION

SUCCESSFUL PROJECTS AND PARTNERSHIPS PROVIDE MUTUAL BENEFIT AND SUPPORT EFFORTS TOWARDS RECONCILIATION

### Goals:

- Build respectful relationships
- Enable dialogue and understanding; and
- Lead the industry by example.

### 2019 Highlights include:

- **Held the 7th annual Gathering Place** at Roundup.
- **Hosted the 2nd annual Reconciliation Breakfast** at Roundup in partnership with Teck Resources Limited.
- **Hosted two Cultural Awareness Training sessions**, one in Vancouver during AME MinEx Talks and the second in Kamloops during the KEG Conference.
- **Declaration on the Rights of Indigenous Peoples Act (DRIPA)** sets out a framework to ensure the laws of B.C. uphold the rights of Indigenous peoples and was enacted in November. AME was engaged in a review of policies, programs and legislation to bring the act into action in B.C. and looks forward to continuing to work with government and Indigenous leaders on the implementation of the act as it is enshrined into the various laws on B.C.
- **Partnered with the Tahltan Central Government on an op-ed** in the Globe and Mail and Black Press news outlets following the DRIPA legislation introduction. This was the first collaboration between a CEO of AME and an Indigenous leader published in a national newspaper.
- **Early Engagement Planning Tool** The Indigenous Relations and Reconciliation Committee, staff and Hatfield Consultants have developed an early engagement planning tool that will be released in early 2020. This tool is aimed at helping AME members to with undertaking engagement with Indigenous groups as part of their exploration projects.



## MEMBERSHIP BENEFITS AND SERVICES

LEADERSHIP, NETWORKING AND ACCESS TO EXPERTISE.

### Goals:

- Provide policy leadership and progress;
- Provide tools and best practices for members;
- Increase membership value proposition by progressing key issues; and
- Increase awareness of full value proposition to membership.

### 2019 Highlights include:

- **AME membership** represents as of December 2019, 397 Corporate Members and 4326 Individual Members.
- **Member survey conducted** with an 11% response rate or 721 responses; a summary of the survey was released to all members in Spring of 2019.
- **Hosted a member's reception at PDAC** for the release of the British Columbia Mineral and Coal Exploration survey, a joint initiative between EY and the Ministry of Energy, Mines and Petroleum Resources.
- **Held the first AME MinEx Talks** in April. This event featured discussions centered on ways to approach the rapidly changing landscape of the mineral exploration sector by providing the opportunity to share stories, practices and insights in the industry.
- **One-day short courses** were held in conjunction with AME MinEx Talks; Mineral Exploration and Mining Essentials; Environment, Health & Safety, Risk Management and Resources for Mineral Exploration Life Cycle and Indigenous Relations and Cultural Awareness Training.
- **Held numerous member-networking events** throughout the year in addition to Roundup. Highlights included: The Annual Charity Golf Tournament in May, Old-Timers' summer lunch in July, Past Presidents and Chairs annual lunch in October and our annual Christmas Open House in November.
- **Through the quarterly Mineral Exploration magazine, monthly blog online and AME e-News** our members are kept up-to-date on AME's advocacy work and industry stories.
- **Held three permitting workshops**, one in April in Kamloops, another in May during Minerals North in Chetwynd and one in November in Cranbrook.
- **Held two environment, health and safety workshops** for attendees ranging from high school and university students through exploration managers in Vancouver, at UBC and at the Kamloops Exploration Group conference.
- **Collaborated with PDAC on the 14th annual national environment, health and safety survey** – confirming that mineral exploration continues to be safer than most industries and continuing to inform AME resources.
- **The Mentorship Program** launched in January at Roundup, kicked off in April, and continued with a Mentor and Mentee mixer in September.
- **Continued developing the member tools:** The Indigenous Relations Early Engagement Planning Tool, Reclamation for Exploration Tool and the Operational Risk Management training module for completion by Roundup 2020.
- **The AME Social Responsibility and Community Engagement Video Series** was initiated and the first two videos were launched.

## Highlights of the 36th Annual AME Roundup Conference 2019, “Elements for Discovery,” include:

- **Six short courses** we offered to build knowledge and provide opportunities for professional development for our members.

- **150 students attended the Student Industry Networking Event** connecting industry leaders and the next generation of mineral explorers and geoscientists.

- **The Innovation Hub.** Seven participants highlighted their innovative achievements and showcased the re-imagining of the industry and how it is moving into the 21st Century. There were two full days of panels and presentations on The Innovation Stage, and the first **Social Innovation Panel** on Thursday morning opened with a speech from B.C. - **Discovery Day**, a family-friendly public outreach event, was well-attended and is quickly becoming an annual event for many rock-hounding families.

# TREASURER'S REPORT ON BEHALF OF AME'S FINANCE AND AUDIT COMMITTEE



Members of AME's Finance and Audit Committee review, on behalf of the Board of Directors, the preparation of the annual operating budget and the quarterly and annual financial statements, as well as our returns on investment assets and other related matters.

Our financial results for the fiscal year reflected an operating surplus of \$47,898 compared to a surplus of \$683,711 in 2018. Our 2019 operating budget as initially approved was balanced, and no use of any operating surplus carry forward was planned. However, based on the fiscal 2018 the board approved additional operating and capital expenditures of approximately \$435,000 and to move an additional \$300,000 to the restricted contingency reserve fund. The majority of the additional planned expenditure was not made and has been approved as part of the 2020 budget going forward. AME takes a deliberate, multi-year approach to financial management rather than a hurried and arbitrary spending at year end in order to 'use up' the operating surplus generated in a particular year. Formal accounting and reporting standards require the preparation of financial statements on an annual basis. However, it is unwise for us, in the context of our history, continuity and ongoing mission, to over-emphasize the importance of the financial surplus or deficit of any particular twelve-month fiscal period.

AME's internally-restricted net assets were increased to \$2.5 million during the year ended August 31, 2019, as a result of the allocation noted above. The origin of these restricted funds was the sale of our building on Hastings Street in 2003 and in general, our net assets have fluctuated between \$2.2 million and \$3.2 million over the past 15 years. We operate in a sector where volatility and unpredictability are prevalent, and the overall maintenance of our net assets has allowed us to finance operating deficits in some years, and putting aside reserves from a surplus in better years. AME continues to manage its financial resources with a view to balanced operations and maintenance of our assets to sustain us for many years to come.

Our financial statements have been prepared in accordance with Canadian generally accepted accounting principles applicable to not-for-profit organizations and reflect, in certain areas, management's best estimates based on information currently available. AME has developed and is maintaining a system of internal controls designed to provide reasonable assurance that its assets are safeguarded, transactions are authorized, and financial information is reliable.

The following summary annual financial statements have been prepared by, and are the responsibility of, myself in consultation with our senior management. They faithfully reflect and represent what we believe to be the most relevant elements of the full version of the audited financial statements, which are, as always, the responsibility of both the Board and myself. Our external auditors are PricewaterhouseCoopers LLP, and their report which follows outlines the scope of their examination and unqualified opinion on these summary financial statements.

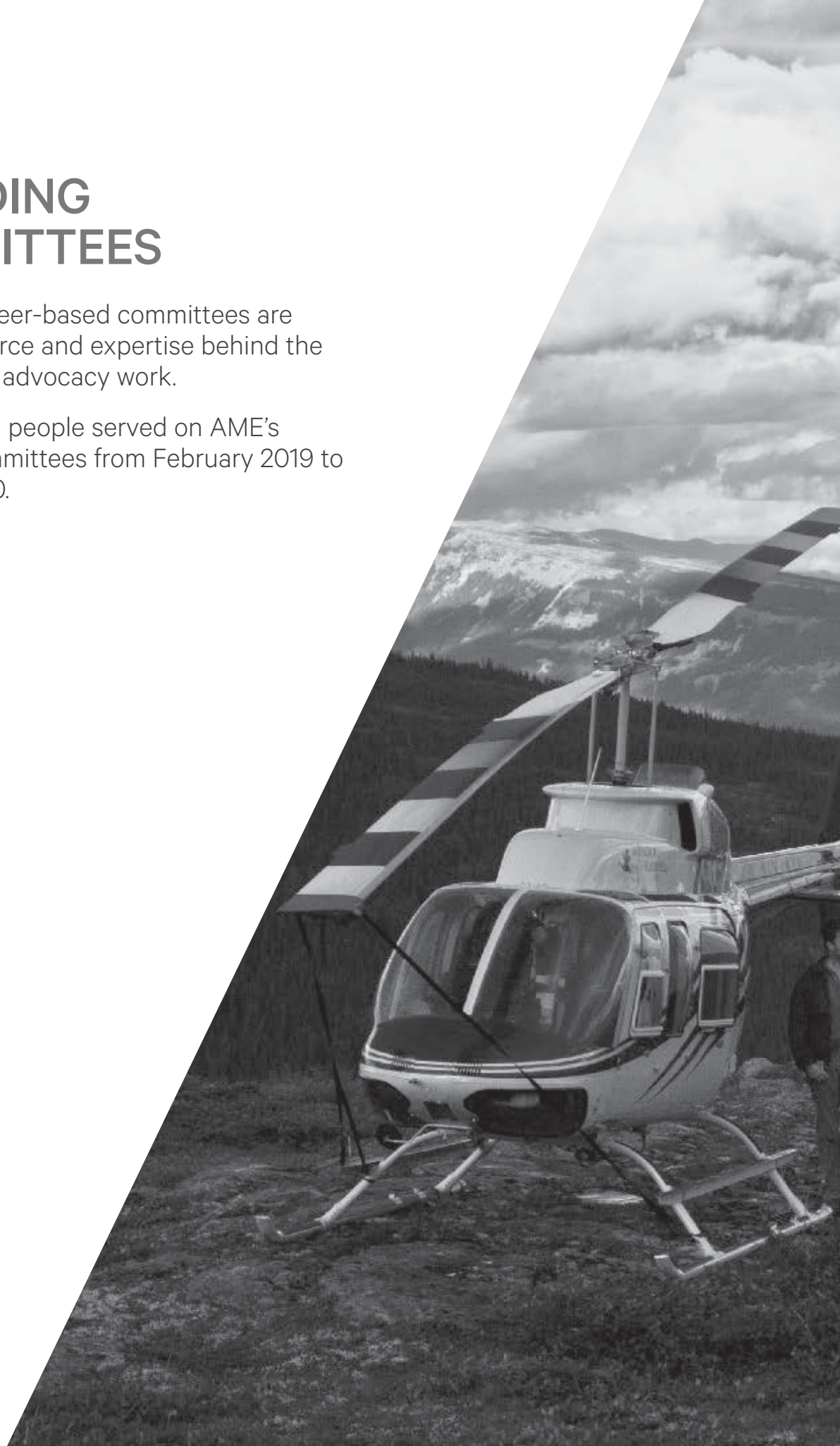

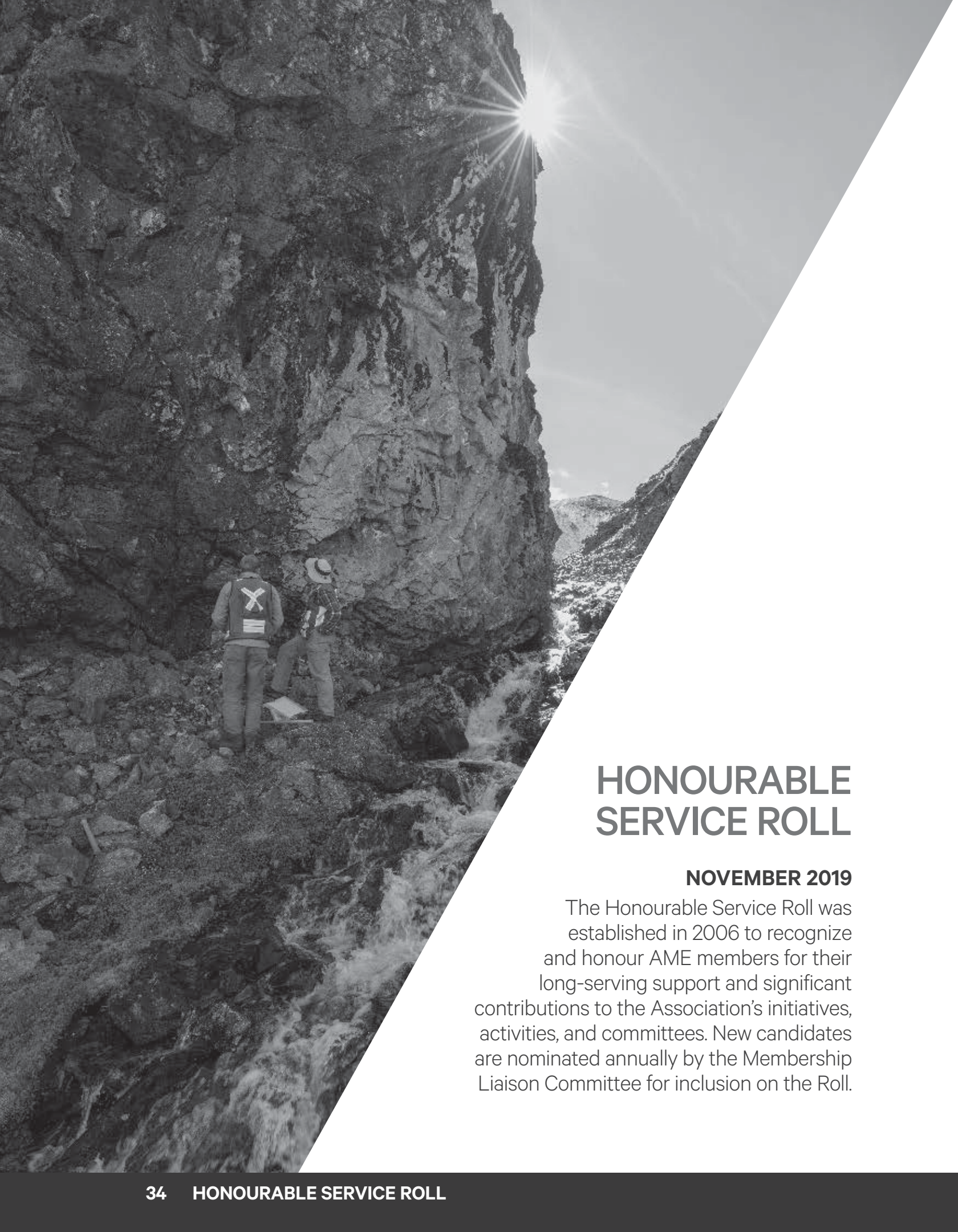

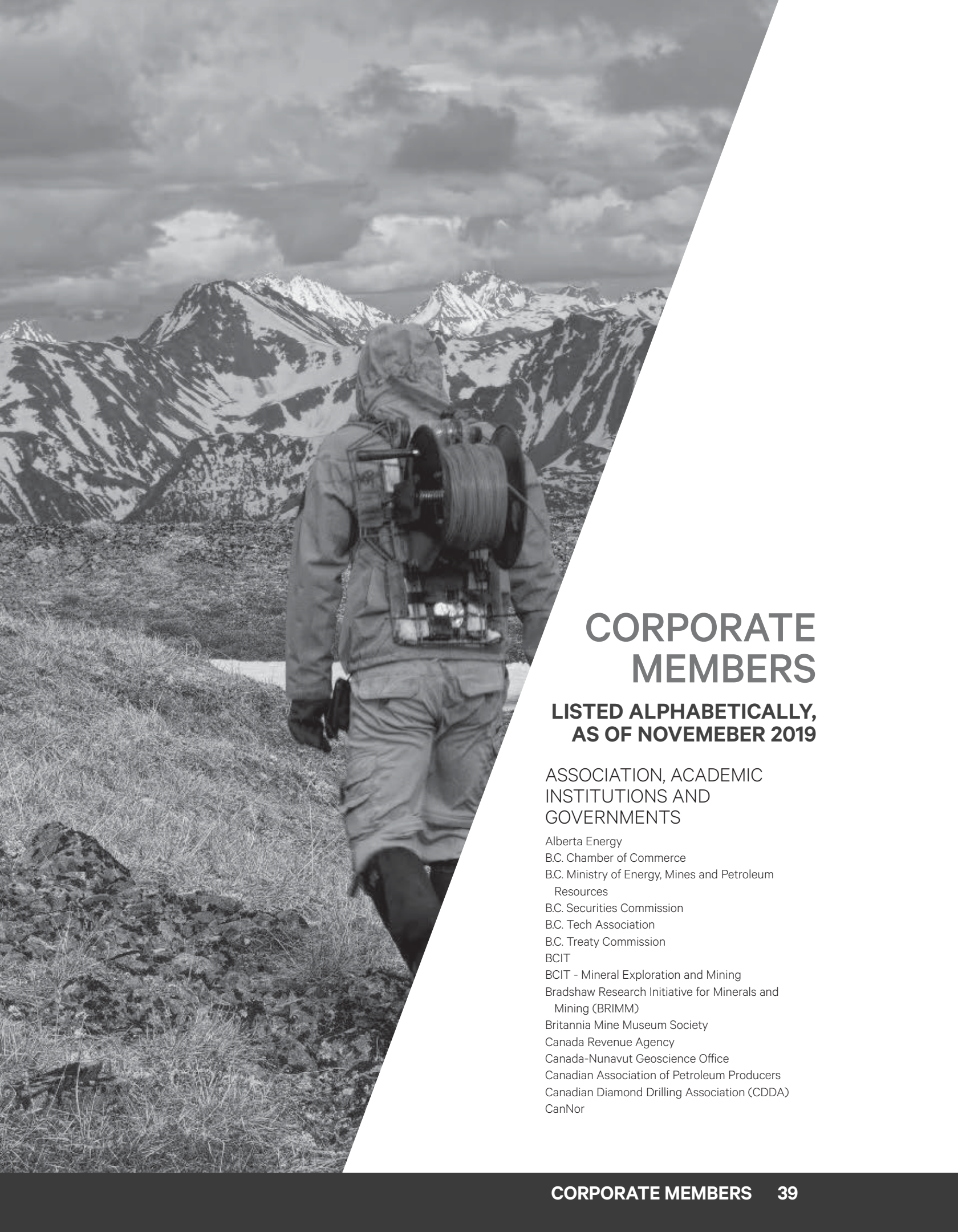
